# Delegate's Report January 2022

Greetings! I'm Grace, and I'm Area 43's Delegate to the General Service Conference. Your Alternate Delegate is Sue W. Together, Sue and I form the Delegate team.

### 72<sup>nd</sup> General Service Conference

Items of importance to AA as a whole are discussed and voted at the annual General Service Conference (GSC). Our focus right now is on the upcoming Conference, which will take place at the end of April. The aim of every Delegate is to arrive at the Conference fully "informed" on the views of their Area on the items which will be on the Conference agenda — and the larger "context" in which those ideas originated.

#### A. Pre-Conference

The first decision Sue and I made together is to offer a Pre-Conference Process, rather than a Pre-Conference Event. The Pre-Conference Assembly in March will be one of multiple opportunities for the AA Groups and AA Members in NH to learn about the agenda items that will be reviewed and voted at the GSC.

The agenda items with short (summary) background will be posted on the Delegate's Corner webpage by the end of February. The complete, unabridged, many-many-many-page background material file will also be posted on the webpage.

We will be offering GSC Sharing Sessions. There will be a "focus" for the first part of each session, such as Literature or Corrections, where we will devote time to the agenda items that fall into those specific categories. Time will also be set aside at the end of each session for folks to ask questions about any of the agenda items. We are committed to offering 2 Virtual and 2 In-Person GSC Sharing Sessions – and the final one will be at the Pre-Conference Assembly.

The next decision we made was to use an accessible and inclusive format for gathering the Area Conscience on the agenda items. This will take the form of an online survey, and the survey will be available for 2 weeks to give everyone plenty of time to participate.

The survey will "launch" at the Pre-Conference Assembly on March 26<sup>th</sup>. The survey will remain open during the Area 43 Convention weekend, and will not close until Sunday, April 10<sup>th</sup>, so it will also be available during the NHSCYPAA weekend.

#### **B.** Post-Conference

At the Post-Conference Assembly, the Delegate provides a report on all the items that were discussed and voted at the General Service Conference. The Assembly is scheduled for May 21<sup>st</sup>. In addition, Sue and I would like to visit every District in late May or June. DCMs, please look at your schedule of monthly meetings and let us know the date you would like us to visit with you. June seems a long way in the future (especially when NH is frozen solid), but please consult your calendars and get back to <a href="mailto:delegate@nhaa.net">delegate@nhaa.net</a> as soon as possible so we can get plans in place.
