General Service Board Inventory

In my oral and written reports on the General Service Conference, I talked about a Floor Action at the Conference asking the Board to conduct an inventory prior to next year's Conference. This was suggested as a way to unite and move forward after the difficulties associated with the Board Chair's resignation in January. Unifying all members of the Conference (delegates and trustees) will hopefully be an outcome of the inventory for 2 reasons: First, an inventory is our mechanism to reflect and grow. Second, a working group consisting of delegates and trustees has been formed and is tasked with developing the inventory "questions."

The working group has met, and additional meetings will be upcoming. Potential questions are being formulated. The plan (at this point) is for the Board to conduct its inventory during the quarterly Board meeting at the end of October.

Search for new Chair of the General Service Board

As shared in my oral and written reports on the General Service Conference, one Class A trustee position was left vacant and we did not elect a new Board Chair. The rational was to allow ample time for a robust and thoughtful selection process.

Our new NE Regional Trustee, Ken T, reported that the criteria for eligibility was that the individual had previously served as a trustee and 10 individuals indicated they were willing to stand for the position. This represents a lower number of potential candidates than in previous nomination cycles. Also, the Board Chair has typically always been a Class A trustee (non-alcoholic), although this is not required under the Board's bylaws. Of the 10 resumes received, only one was from a previous Class A trustee and the other 9 were from past Class B trustees.

The trustees Nomination Committee reviewed all the resumes and held virtual interviews with the candidates this past week. A "short list" will be presented to the full Board at their meeting at the end of the month. From that pool, individuals will be selected for a second, in-person interview which will happen during the Board meeting at the end of October. More to follow \odot

Finances at GSB, GSO, AAWS and Grapevine

This information comes from the *unaudited* Board Finance Report for the 6-month period ending June 30, 2023.

• 7th Tradition contributions have come in at 102% of the YTD budgeted amount – good news!

- Contributions declined in 2022 compared to 2021, and still remain below that amount bad news!
- Sales of AA literature have been very strong. There was a surge in orders in March (before the April price increase), and the June orders are also ahead of projection. Overall, gross sales are 108% of YTD budget amount good news!
- Gross profit from sales of AA literature has risen substantially this year due to the price increase good news!
- When we average the literature net profit margin for the 6 months (3 months before the price increase and 3 months after), the Cost of Goods Sold (percentage it costs to print, sell and ship the books) still remains too high at 48.8% bad news!
- Do not ever, ever, ever buy AA literature from Amazon. Buying from AAWS directly or through our NHAA Service Office accomplishes 2 things: the books cost less than they do at Amazon and you are supporting Alcoholics Anonymous

Safety and AA

On the 2023 Delegate's Survey, respondents were asked to share what unsafe behaviors they had personally witnessed at AA meetings in the last year.

YIKES! We have seen some unpleasant stuff.

If the meeting doesn't feel safe, a newcomer may not come back.

In my report to you about the survey results, I said we would create opportunities to talk about this – in a safe and respectful way. Look forward to the first one at the August Assembly. We have LOTS of talent in the Fellowship, so we are asking a member with experience in talking about difficult subjects (you know…like feelings!) to lead a workshop.

Bridging the Gap



On the 2023 Delegate's Survey, over 65% of respondents said they would feel comfortable volunteering as a Temporary AA Contact for someone leaving a treatment facility.

But...only 12% of survey respondents are currently Bridging the Gap volunteers.
