The contributions of groups across the US and Canada sustain the General Service Office in New York. Without GSO, we could not effectively carry the message – the staff at GSO coordinate publication of our literature, provide materials to help committees do their work, create public information videos and PSAs…the list goes on and on. As I get updates on finances in NY, I will be passing along the information.

Through the first 2 months of 2022, GSO is right on target in contributions and literature sales, and slightly under on expenses – just what every Treasurer likes to see! GSO maintains a prudent reserve – which currently sits at 7.85 months of budgeted operating expenses for GSO and Grapevine.

#### **Armed Forces AA Member Interview Project**

The Trustees' Committee on Cooperation with the Professional Community/Treatment and Accessibilities is initiating the production of interviews from members of the United States and Canadian Armed Forces.

The goal of this effort is to improve A.A.'s outreach and identification with members of the U.S. and Canadian military. A major part of this work will be the production of several audio/video products where individual A.A. members who are currently serving or recently retired will share their experience with particular emphasis on recovery in A.A. while serving in the military.

### There is a need for volunteers to help with this important project!!

The committee is looking for A.A. members who are willing to be interviewed for this project. They would like to have representation from all Services from Canada and the U.S. – A.A. members from

all ranks, all across the spectrum of age, gender, orientation and varied operational experience speak to what it is like to recover and stay sober while serving in the military. The anonymity of all involved will maintained.

Part of the "position description' for Alternate Delegates is they should be ready and prepared to attend General Service Conference if, for any reason, the seated Delegate cannot attend. There has been lots of chatter this year about COVID and the need to Alternate Delegates to "really" be ready to go. I can assure you that Sue W is amply prepared should she need to step in. However, from 1954-2021, there have only been 26 instances where an Alternate Delegate was "admitted" to the Conference in place of that Area's Delegate.

Twice over that 67-year period an **Area Chairperson** was "admitted" to the Conference because neither the Delegate nor Alternate Delegate could attend.

In 1984, the **Area Treasurer** from Central and Southeast Ohio was seated as a Conference member, since neither the Delegate nor the Alternate Delegate nor the Chairperson from that Area was able to attend.
